NOTICE is hereby given under Section 4 of the Land Settlement Ordinance that if no claim to any one of the lands specified in the Schedule hereto or to any share of or interest in such land is made to the undersigned** within a period of three months from the 8th day of October, 1982, such land will be declared under Section 5 (1) of the aforesaid Ordinance to be the property of the State and will be dealt with on account of State.

(b) A claim to a right of way over the said lands or any of them is a claim to an interest in the land or lands.

(c) Lots that are not expressly mentioned in the Schedule will not be dealt with under this notice even if they are situated within the boundaries specified. No claim need therefore be made regarding any such lot.
