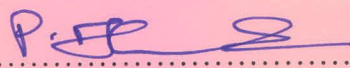

## SPECIAL CONDITIONS

1. The land illustrated in this document, must be handed over to the Divisional Secretary of **Kuchchaveli, Trincomalee**, and no sooner than the said land was no more needed by the Department / Institute of **Assistant Superintend of Police Quarters, Pulmoddai-04**
2. This land must not be handed over by the Head of the department / Establishment permanently or temporarily to the other Government Department or any the officer without the approval, which was duly obtained, from the land commissioner General / Provincial Land Commissioner.
3. The any tree situated in the land, must not be felled without obtaining the prior approval of the Divisional Secretary.
4. Prior to use this land, which was handed over to the Department / Establishment, for any other purpose other than the purpose of that department, the approval must be duly obtained from the Land Commissioner General / Provincial Land Commissioner.
5. The Divisional Secretary has power to vest that land in the Government on the occasion of the land was not used for the due purpose.
6. The Head of the Department / Establishment does not have power to sell the permanent products, generated by this land, To sell or auction such products will be carried out by the Divisional Secretary and a tax which will be imposed by the Divisional Secretary, must be paid the Head of the Department/ Establishment or Employee of the Establishment or any other person who leased out this land
